## **TYNDP**

In accordance with Article 22 of EU Directive 2009/73/EC¹ (the "**Directive**") and Part 4 of Statutory Instrument S.I.16 of 2015², GNI, as Ireland's gas Transmission System Operator ("**TSO**"), is required to submit to the Commission for Regulation of Utilities ("**CRU**"), on an annual basis, a ten year national development plan based on existing and forecast supply and demand having consulted all the relevant stakeholders. GNI is also obliged to submit a long-term development statement to the CRU in accordance with condition 11 of its TSO licence. The TYNDP also satisfies the requirements of section 19 of the Gas (Interim) (Regulations) Act 2002, as amended, which requires the CRU to monitor the security of supply.

The CRU launched a public consultation (CRU/18/269) on the TYNDP which commenced on the 21 December 2018 for a six week period.

In response to the CRU's public consultation, the CRU received responses from;

- Bord Gáis Energy (BGE);
- An Taisce:
- ESB Generation and Trading
- Friends of the Irish Environment;
- Safety Before LNG;
- Not Here Not Anywhere;
- Environmental Protection Agency; and
- Western Development Commission (WDC).

Having considered the responses received to the public consultation, GNI revised the TYNDP to clarify the procedures and policies adopted by GNI to ensure that potential environmental impacts for all of its project are considered at the earliest possible stage of each project. GNI has also undertaken to screen the TYNDP in accordance with article 3(4) of the SEA Directive<sup>3</sup> and in accordance with Article 6(3) of the Habitats Directive<sup>4</sup> to determine if the TYNDP is likely to have significant environmental effects.
